

ADDITIONAL INFORMATION ON DATA PROTECTION:

How did we obtain your data?

The personal data processed by MAPFRE RE were obtained from the receipt of your professional business card by MAPFRE RE in accordance with the data protection legislation in force.

The collected data are categorised as identifying information. Under no circumstances will they be specially protected data.

Who is in charge of processing your personal data?

The controller of the data processing of the personal data that is provided is:

What is the purpose of processing your personal data?

MAPFRE RE will process any personal data it obtains for the following purposes:

- Establishing and/or strengthening commercial or professional relations with the entity that you represent;
- Event invitations and training courses;
- Sending communications or newsletters;
- Maintenance and integral management of its relationship with MAPFRE RE's Group; and
- For sending information and proposals offering MAPFRE RE's products and services;

How long will we keep your personal data?

The personal data thus obtained will be held for a certain amount of time based on the following criteria: (i) the legal obligation to hold them; (ii) in view of any liabilities derived from handling the data; and (iii) requests for deletion from the interested party in applicable situations.

What are the legal grounds for processing your data?

The legal basis for processing your data under the purposes included in the section entitled "*Under what authority do we process your personal data?*" is MAPFRE RE's legitimate interest as the data controller. This legitimate interest is justified by:

- The data was obtained after MAPFRE RE received your professional business card, at a professional fair, at an event where you provided your data to MAPFRE RE or by means of any type of communication intended to strengthen commercial or professional relationships between MAPFRE RE and the entity you represent and was, therefore, legitimately obtained.
- The type of data that are handled (solely identifying data and contact information). Since it is not special category data that are being handled, the fundamental rights and interests of the interested party are being respected.
- The interested party's ability to object to data processing at any time in a simple and clear manner.

To which recipients will your data be communicated?

MAPFRE RE may only communicate your data for the purposes specified in the section entitled "*What is the purpose of handling your personal data?*"

- To the different service provision companies of the MAPFRE Group for the due provision of the service.
- To third-party companies with whom collaboration agreements have been entered into for the provision of qualified services requested by the client.
- To authorities, regulators or governmental bodies in cases required by law, local regulations or in compliance with regulatory obligations.
- Furthermore, any company in the MAPFRE Group (www.mapfre.com), or its subsidiaries and investees may communicate these personal data to any of the aforementioned entities for the purpose of maintaining integrated and centralised management of interested parties' relationships with the various MAPFRE Group companies, and interested parties may benefit from access to their data from any of these companies, in all circumstances in accordance with the applicable personal data protection legislation, with no need for the interested parties to be notified of each first communication that is made.

International data transfers may be made to third parties or international organisations, whether there exists a European Commission decision on their adequacy or not. International transfers to countries that cannot guarantee an adequate protection level shall be made on an exceptional basis for the fulfillment of the stated purposes.

What are your rights?

Under the terms and within the scope established in prevailing regulations, any person is entitled to request the following rights:

- **Access:** Know the personal data that is processed by MAPFRE RE.
- **Rectification:** Request the correction of any inaccurate data.
- **Erasure:** Request the deletion of data when they are no longer necessary for their original intended purpose.
- **Restriction:** Request that the processing of the data may be limited, if for example the data is inaccurate or the data processing is not legitimated. Data may be processed for the exercise of claims, the protection of the rights of another person or for public interest reasons.
- **Opposition:** To oppose to the processing of their data, in which case MAPFRE RE will no longer process the data except for the development of the contractual relation, if any, or for the exercise or the defence of possible claims.
- **Portability:** To receive a structured, shared use and legible format of the personal data or to transfer the request to another processor when technically possible.

It is also possible to withdraw, at any moment, the consent for the data processing of the data, if any.

The before mentioned rights may be exercised directly by the data subject or through its legal or voluntary representative, in writing to OFICINA CORPORATIVA DE PRIVACIDAD Y PROTECCIÓN DE DATOS, Carretera de Pozuelo, 52,28222, Majadahonda, Madrid.

Additionally, the data subject may submit a claim to Agencia Española de Protección de Datos particularly when he/she considers that the data has not been processed according to the regulation, through the website provided for such end by the corresponding Control Authority.
